MISSOURI CHARGE CODE MANUAL INSTRUCTIONS

Enter the four-digit NCIC code with each charge on the front of the fingerprint card. Enter the Missouri statute, U.S. code, or local ordinance number, and Missouri charge code on the back of the card.

Locate these codes in this manner: Look in the index below for the major category and page. After locating the major category in the manual, search in the column entitled *Description* for the appropriate offense. You will find the statute number or U.S. code number, the penal range, five or more digits of the Missouri code, and two or more digits of the NCIC code on the same line as the offense. If only two digits of the NCIC code and five digits of the Missouri code are listed, you must select one of the two-digit modifiers from the range(s) in small print located immediately after the major cateogry description. The eighth digit of the state code is always one of the following:

.0 Not Applicable

.1 Attempt

.2 Accessory

.3 Conspiracy

For example, if a suspect is arrested for being an Accessory to Murder of a Police Officer in the 1st Degree With a Gun, you would look under Homicide and locate Murder 1st Degree. That NCIC code is 09 and that Missouri code is 10021. Now check in the modifier range for the proper modifier code. In this case it would be Willful Kill - Police Officer - Gun, code 07. The code 07 will be the third and fourth digits of the NCIC code and the sixth and seventh digits of the Missouri code. The eighth digit of the Missouri code will be .2, accessory. This written charge, the NCIC code, the statute number, and the Missouri code are illustrated below in their completed form in their respective prescribed locations.

This manual has been distributed by the Missouri State Highway Patrol. Direct inquiries relating to the codes and their usage to the Criminal Records and Identification Division, Missouri State Highway Patrol, Post Office Box 568, Jefferson City, Missouri 65102, telephone (314) 751-3313.

Missouri Statutes 43.500 through 43.530 RSMo., mandate that persons arrested for specific charges be fingerprinted and that a description of the arrest charges and a fingerprint card be forwarded to the Criminal Records and Identification Division, Missouri State Highway Patrol, which has been designated as the central repository. This manual has been designed to indicate which charges are reportable and require fingerprints. ONLY THOSE OFFENSES WHERE THE CHARGE CODE IS PRINTED IN RED REQUIRE FINGERPRINTS. Fingerprinting of individuals arrested for all other charges is at the discretion of the arresting officer or agency.
