

What is A Priver Examiner Professional?

Driver examination professionals are responsible for conducting a variety of driver license examinations to determine the eligibility of individual applicants for licensure. The examiner interacts with the public on a daily basis throughout all facets of the driver examination process. They embody the Missouri State Highway Patrol core values of integrity, responsibility, respect, professionalism, compassion, resourcefulness, character, and commitment.



Highway Patrol Driver Examiners:

- Trained to a high level in laws, federal regulations, and procedures to assist the public.
- Operate vision and testing equipment.
- Trained in fraud detection.
- Administer written, vision, and road skills examinations for all classes of driver licenses.
- Ensure Missouri licensed drivers have a level of competency consistent with safe driving habits and practices, as well as demonstrated skills and knowledge of Missouri laws related to traffic safety.
- Administer the written and skills examinations to obtain a motorcycle instruction permit or motorcycle license.
- Answer inquiries regarding the license application procedure, the CDL program, Missouri licensing regulation, etc.
- Encourage and inform applicants concerning examination study or reason for examination failure.



Highway Patrol Commercial Driver Examiners and Auditors:

- Trained to a high level in laws, federal regulations, and procedures to assist the public
- Selects types of commercial driver license examinations by verifying classification and endorsements needed for the vehicle to be driven and cargo to be hauled.
- Administers the CDL skills tests. CDL skills examinations require the examiner to ride in all types of vehicles including, but not limited to, tractor-trailers, large trucks, buses, vans, cars, etc.
- Encourage and inform applicants regarding the CDL examination results or reason for examination failure.
- Provide training to third-party CDL examiners.



- Be at least 21 years of age.
- Possession of a high school diploma or equivalent.
- Must possess or obtain a valid driver license.
- Be of good character with no convictions or pending indictments for a felony or a crime involving moral turpitude (dishonesty, immodesty, or immorality.)
- Must successfully complete the Driver Examination Basic School as approved by the superintendent of the Missouri State Highway Patrol.
- Must successfully complete the Commercial Driver License Examiner Training Course.
